Danny Taylor became one of the first people in the state of Alabama and one of only a handful of people in the country to successfully complete the educational requirements and pass the exams to become a “Certified Fire Door Inspector”. The program is administered by Intertek Testing Services.

In our previous issue we announced that the 2006 version of NFPA80 will require annual inspections of all fire doors to be performed by individuals who can demonstrate knowledge and understanding of the operating components. NFPA101 recently approved these same inspection requirements.

EVERYTHING IS TURNING GREEN USGBC RELEASES CHANGES TO FSC CREDIT REQUIREMENTS

Recently, the US Green Building Council (USGBC) released revisions on how Forest Stewardship Council (FSC) credits are achieved for LEED New Construction, as well as Commercial Interior projects. These changes directly affect distributors.

The US Green Building Council recently released revisions to how FSC-certified wood credits will be calculated and documented in LEED® projects. These changes require distributors, who do not install, to become FSC Chain of Custody (COC) certified to provide documentation for customers requiring FSC credit for LEED projects.

These new changes state that all “vendors” of FSC-certified products must hold a valid COC certificate. Under the new guideline, a “vendor” is defined as a company that supplies FSC-certified products to LEED project contractors and subcontractors, but does not install the products. A subcontractor is defined as the installer of the finished wood product.

Distributors seeking COC certification must meet the current FSC COC Standard, FSC-STD-40-004 (Version 2-0) and be audited by a FSC third-party certifier. These standards require controls for sourcing, labeling and the sale of FSC-certified products to ensure wood products with FSC claims are originating from well-managed forests.

ESCALATING MATERIAL PRICES

Unprecedented increases in the price of raw material are driving prices for hardware and hollow metal “out the roof.” “We had price increases in January and May and have been informed that prices will increase again before October,” states Sandy Sanders, Vice President of WTA. In addition, with gasoline and diesel fuel over \$4.00 per gallon, freight prices have almost doubled in four months!

Here are some tips for partially protecting yourself from these skyrocketing prices.

1. Make submittals as quickly as possible after being awarded the project and insist on fast turn around for approvals.
2. Order material early. Arrange for storage of the material onsite.

DOOR RELATED INJURIES

STATISTICS:

1. There are over 300,000 door-related injuries requiring emergency room treatment each year.
2. Approximately 45,000 or 15% involve children under age 4.
3. Door injuries result in approximately 25,000 amputations.
4. In just two cases where the fingers were able to be reattached, the settlements had price tags of \$725,000 and \$600,000.

Door related injuries happened at the rate of 1,000 per day and they go largely unreported. This type of injury is largely preventable and there are growing expectations that facilities managers should be doing something about it.

Try this: Put “fingers amputation lawyers” as the search string in Google, hit “go” and you get 111,000 responses. Building owners, tenants and facility operators are increasingly being held responsible for door related injuries.

Doors need not be a danger to staff and visitors or a risk to business survival. Door Safety starts with risk assessment and ends with installing the full range of appropriate safety measures.

Amazingly there are very few regulations. As far as we are aware, none of the States Child Care Licensure Regulations require the installation of finger pinch protection devices. However, there are a number of establishments such as the US Air Force, the General Services Administration, the Department of Defense and the National Resource Center for Health and Safety in Child Care that issue guidelines.

LEED REQUIREMENTS

Quick lessons in meeting LEED requirements for New Construction

Version 2.2, Credit EQ 4.4

Composite Wood and Agrifiber Products

- * To improve indoor air quality this LEED Credit prohibits the use of urea-formaldehyde (UF) resins in composite wood and agrifiber products. The LEED NC 2.2 Reference Guide states, “EQ Credit 4.4 also controls formulation by setting a limit of zero added urea-formaldehyde resins.”
- * “Added UF” means UF glue resins used in the construction of the product, including its components and assembly. LEED gives examples of products and components such as door core, panel substrates, door assemblies, MDF, veneered panels, wheatboard and plywood.
- * Some product components, such as plastic laminate door faces, or finishes such as Marshfield DoorSystems® Environclad UV® finish, will help to encapsulate VOCs and limit off-gassing, but these do not meet the descriptive requirement of zero added UF resins.
- * Door core, crossbands (HDF or MDF) and the entire door assembly should not have added UF resins.
- * If composite wood and agrifiber products contain UF resins, the project will not earn this credit.
